110 I wanted to ask about the tables and chairs they are not here  
111 and I want you to be aware of it.

113 The officer's last workshop meeting brought up about getting  
114 some tie down for the new trailer. I found a place that is in  
115 Lakewood that sells what I think we need for it and it comes out  
116 to like \$180.99 they were closed due to the holiday so I don't  
117 know if they will take a PO I will let you know.

119 We spoke at the workshop meeting about having the vinyl vent  
120 magnetic put on the drops out in the bay. I spoke to people down  
121 in Wildwood the one quote is for one drop which will be \$1757.00  
122 just for one if you want to do the remaining 4 altogether we get  
123 a \$612.80 discount because they only have to come here once at a  
124 cost of \$5,815.20

126 Spoke to people from Watch fire sign in Wildwood they will stop  
127 the next time they are in the area

129 Do you want to get the floors done across the street. A  
130 discussion followed  
131  
132 A discussion was held about the gear  
133  
134 Commissioner Horn said the he spoke to Air and Gas about our  
135 compressors. I talked to their engineer about the door problem  
136 that we had with it they actually were very intrigued by it they  
137 sent there employees down here. Dean said that he explained what  
138 was going on with the door. He said he didn't know of any  
139 recalls on that door and it is an old one. The next time it goes  
140 to call him and he will come down and look at it. We also

141 discovered that the gauges were leaking so I ordered 4 gauges to  
142 replace them. A discussion followed

147 1 - Commissioner Gifford asked Commissioner Horn if he had info  
148 on the gear dryer. Commissioner Horn said he got two price  
149 quotes, one from Air One Equipment for \$8,547.97 and one from  
150 fire fighter one for \$8,222.50 and they are located in New  
151 Jersey for the exact same one. A discussion followed.

152 Commissioner Horn made a motion to purchase a gear dryer from  
153 Fire Fighter One for the price of \$8,222.50. Commissioner  
154 Gifford second, roll call vote, full board yes

155 2- Commissioner Gifford just to go over the grant. We had to  
156 make an amendment to the grant which was actually submitted to  
157 the FEMA today when we did the original grant the equipment that  
158 we specked is no longer available from the manufacturer we had  
159 to make adjustments to the equipment that we are buying. We  
160 worked with Grant Masters just to have him polish it up, we are  
161 waiting to hear from them in the next couple of weeks.

164 New Business:

165 1 - Commissioner Dowling said that he spoke to Armstrong about  
166 the tree out front. He did give me a quote and I think it is a  
167 little high it is \$600.00. The board suggested that we get  
168 another quote.

169 2 - Commissioner Dowling said going back a couple of months ago  
170 that we were looking to purchase tables and chairs at one time.  
171 I did get prices today for a six foot folding table at Costco  
172 they are \$49.99 and padded chair is \$14.99 and a folding chair  
173 which are bigger than these is \$21.99. They have them in stock.  
174 Commissioner Dowling said that the tables and chairs that were  
175 discussed earlier were up at the ball field.

176 3 - Commissioner Horn made a motion to purchase not to exceed  
177 \$200.00 for the rack system for e tracks for the trailer.

178 Commissioner Dowling second, roll call vote, full board ye

179 4 - Commissioner Gifford said that the new grant period for the  
180 fire fighter grants opens on Monday. Since the county is really  
181 moving forward with going with to the 700 our base stations are  
182 over 20 years old. We have a bunch of equipment that meets the  
183 criteria that we can apply for grants for replacement for. So I  
184 think that we should start doing that I doubt we will get it in  
185 the first year but putting it forward. I spoke to Grant Masters  
186 today and they are on board. The new grant is \$2,600.00 I would  
187 like to make a motion that we go with Grant Maters at a cost of

188 \$2,600.00. Commissioner Dowling second, roll call vote, full  
189 board yes  
190 5 - Commissioner Gifford said that myself and the president will  
191 be away for the next regular meeting so I would like to make a  
192 motion that we advertise our meeting change to October 24, 2018  
193 at 7:00 PM. Commissioner Gifford made a motion to change the  
194 date of the next regular meeting to October 24, 2018.  
195 Commissioner Dowling second, roll call vote, full board yes  
196 6 - Commissioner Gifford said that this my recommendation on the  
197 vinyl vent at this point. Just see our finances are going in  
198 November so we could make a line item transfer. I think we  
199 should go for the four instead on one. Commissioner Gifford made  
200 a motion the table the vinyl vents to a later meeting.  
201 Commissioner Horn second, roll call vote, full board yes
