#### SHARED SERVICES AGREEMENT

### BOROUGH OF SEA BRIGHT and the TOWNSHIP OF OCEAN FIRE DISTRICT NO. 2

(January 1, 2019 - December 31, 2019)

THIS AGREEMENT, made this fifth day of January 2019.

BETWEEN:

**THE BOROUGH OF SEA BRIGHT,** a municipal corporation of the State of New Jersey having its principal offices located at 1167 Ocean Avenue, Sea Bright, NJ 07760 hereinafter referred to as the "Borough".

AND:

THE TOWNSHIP OF OCEAN FIRE DISTRICT NO. 2, located at 2001 Sunset Avenue, Ocean, New Jersey 07712 hereinafter referred to as the "DISTRICT".

**WHEREAS**, the **District** employs a Fire Inspector who utilizes a vehicle provided by the **District** in the performance of services; and

**WHEREAS,** this individual is also employed by the **Borough** and wishes to use the vehicle to provide services for the **Borough** in the capacity of Fire Official and Housing Inspector; and

**WHEREAS**, the entities have reached an agreement to allow for the use of the vehicle and various equipment contained therein.

**NOW, THEREFORE, BE IT RESOLVED,** that in consideration of the promises exchanged herein, it is agreed as follows:

- 1. The **Borough** shall provide payment on an annual basis of \$800.00 for the use as **"Fire Official"** and \$400.00 for the use as **"Housing Inspector"** for a total of \$1,200.00 as set forth above and to assist thereby in many of the costs incurred concerning the vehicle and equipment.
  - 2. The agreement shall be approved by resolution of each of the entities.
